



20 Green Card Marriage Interview Questions & Answers

Basic Relationship Questions

Q1: How Did You Meet, and When?

The interviewer will ask you this question to verify that your relationship began naturally and genuinely. They're looking for consistency with your forms, as well as personal details that reflect a real connection. It's also a way to observe how naturally and confidently both spouses recall shared history.

Sample Answer

"We met in October 2019 through a mutual friend who invited us both to a game night. Neither of us was really expecting anything—we just went to hang out—but we ended up talking for hours. After that night, we stayed in touch and started texting pretty much every day. A week later, we went out for coffee, which turned into dinner and a long walk. That was our first official date, and from there, things developed naturally. We started seeing each other regularly, introduced each other to our families within a few months, and really built a strong connection early on. It's been a steady, committed relationship since then."

Q2: Who Sent the First Message? When and Where Was Your First Date

USCIS asks this to assess whether the relationship developed naturally and whether both partners recall key moments similarly. These kinds of details help verify that the marriage is real—not staged—and that both spouses have shared experiences they can speak about comfortably.

Sample Answer

"I sent the first message. We met through a dating app in November 2020, and I liked her profile because it mentioned a book I had just finished reading. I sent a message about it, and we hit it off right away. We talked online for about a week before meeting up in person. Our first date was at a small Italian café downtown—nothing fancy, just a cozy place where we could really talk. We were both a little nervous, but the conversation flowed easily. We ended up walking around the neighborhood after dinner and talking for hours. That date really set the tone for everything that followed—it just felt easy and real."

Q3: When Did Your Relationship Become Serious, and How Did You Know

This question helps determine how your relationship progressed over time and whether the commitment developed in a genuine, believable way. They want to hear specific milestones or emotional turning points that show real connection—not just vague or rehearsed answers.

Sample Answer

"Our relationship started getting serious about three months after we began dating, around February 2021. We had been spending a lot of time together—talking every day, meeting each other's friends and families, and supporting each other through everyday life. I think the turning point was when my dad had a health scare, and she was there for me every step of the way. That kind of support showed me that this wasn't just casual—we were really becoming part of each other's lives. After that, we started having more serious conversations about our future together, including marriage and where we wanted to live. It just felt like we were building something long-term."

Q4: Who Proposed and How Did It Happen

USCIS asks about the proposal to verify the relationship evolved naturally and involved personal, memorable moments. A genuine couple will usually recall the proposal clearly and with emotional or situational detail. They also want to confirm that both spouses have the same version of this story.

Sample Answer

"He proposed in June 2021 while we were on a weekend trip to Asheville. We were hiking near a waterfall, and he asked me to stop so he could take a picture—then he got down on one knee and asked me to marry him. It completely caught me off guard, in a good way. He had even arranged for someone nearby to take photos without me knowing. It was simple, sweet, and very us. We had talked about marriage before, but I didn't expect it to happen that day. I said yes right away, and we celebrated with dinner that night back in town."

Wedding & Honeymoon

Q5: When and Where Did You Get Married, and Who Attended

This question checks for consistency with your paperwork and helps verify whether your wedding was a legitimate event. They're not looking for a lavish ceremony—just details that show it was a real, documented marriage. Knowing who attended and what the event was like can further prove the relationship is genuine.

Sample Answer

"We got married on October 15, 2022, at a small ceremony at the county courthouse in Austin, Texas. We kept it simple because we were focused on getting the paperwork started and didn't want to delay the process. My sister and her husband came, along with two of our close friends who served as witnesses. Afterward, we had dinner at a nearby restaurant with everyone who attended. We do plan to have a larger celebration later with extended family, but for us, the courthouse wedding felt right—quiet, meaningful, and stress-free."

Q6: What Was Your Wedding Like? What Food Was Served

This question helps determine whether your marriage was a real, shared experience. Officers listen for specific details about the event—such as who attended, what kind of ceremony it was, and how the day felt. It's not about how big or expensive the wedding was; it's about whether both spouses can talk about the event naturally and consistently.

Sample Answer

"Our wedding was small but really meaningful to us. We had it at a local park on a sunny Saturday afternoon, surrounded by about 20 of our closest friends and family. We both wanted something low-key and personal, so we kept the decorations simple—just some string lights, flowers from a local market, and a playlist we made together. My cousin officiated, and it felt more like a family gathering than a formal event, which is exactly what we wanted. After the ceremony, we all went to a nearby restaurant we love and had a buffet with grilled chicken, roasted vegetables, pasta, and a small dessert bar with cupcakes and fruit tarts. Everyone said it felt warm and relaxed, and we were just happy to celebrate with the people who've supported us."

Q7: Did You Go Anywhere for Your Honeymoon? If So, Where

This question checks whether you and your spouse shared meaningful time together as newlyweds. A honeymoon isn't required, but if you did travel, officers want to hear matching stories and basic details—when you went, where you stayed, and what you did. It's one more way to confirm your relationship is real and ongoing.

Sample Answer

"Yes, we went on a short honeymoon about a week after the wedding. We both had limited time off, so we decided on a long weekend in Charleston, South Carolina. It's only a few hours from where we live, but we'd never been there before and wanted something relaxing but still special. We stayed at a cozy bed and breakfast that had a lot of charm, and spent our days exploring the historic district, walking along the waterfront, and trying out different restaurants and bakeries. One afternoon we took a carriage tour, which ended up being one of our favorite parts of the trip. It wasn't extravagant, but it gave us a chance to slow down and enjoy that time together before jumping back into everyday life. We still talk about going back someday and doing a longer version of the trip."

Daily Life & Household

Q8: What is a Typical Weekday Morning Like for You Both

This question helps verify that you live together and share a real daily routine. Officers are looking for simple but believable details that show you know how your spouse spends their time and what your mornings look like together.

Sample Answer

"A typical weekday morning starts around 6:30 a.m. I usually get up first to make coffee and pack our lunches while they take a quick shower. We like to eat a light breakfast together—usually toast or yogurt—before we both start getting ready for work. It's a little rushed, but we always make a point to check in with each other before heading out the door. We've fallen into a rhythm that just works for both of us."

Q9: Who Usually Wakes Up First

This question checks whether you know each other's routine and habits. It may seem small, but mismatched answers could raise doubts about whether you actually live together.

Sample Answer

"Usually, I wake up first around 6:30 a.m. I'm more of a morning person, so I take care of small things like starting the coffee, feeding the dog, or packing lunch. My spouse gets

up about 20 minutes later, and by that time I've already started getting ready for work. It's a small part of the day, but it sets the tone for everything else."

Q10: How Do You Divide Household Chores

This question is meant to show how you function as a household. Officers want to see that you've established a shared life and responsibilities—not just living in the same space but cooperating as a couple.

Sample Answer

"We've found a system that works really well for us. I usually handle the kitchen and the laundry, while they take care of vacuuming and taking out the trash. We both chip in on dishes and grocery shopping, depending on who's home first. On weekends, we do a deep clean together and knock out anything we missed during the week. We don't keep score—we just try to keep things balanced and fair."

Q11: Who Cooks? Who Cleans

This is another way to verify your shared domestic life. It also shows whether your answers match your spouse's and reflect a lived-in relationship.

Sample Answer

"We both cook, but I probably do it more often since I enjoy trying new recipes. My spouse usually handles cleaning up afterward—especially the dishes, which I don't mind skipping! On busy days, we might just do something simple like frozen meals or takeout. We're both pretty flexible and try to keep the house tidy as we go, so it never really piles up."

Q12: What Kind of Daily Communication Do You Have When Apart? (Texts, Calls)

They want to know if you're genuinely involved in each other's lives when you're not physically together. Consistent, natural communication patterns help reinforce the authenticity of your relationship.

Sample Answer

"When we're apart during the day, we usually text each other a few times—just checking in or sharing something funny. If either of us is having a stressful day, we'll make time to talk during a break. We always call each other after work just to catch up and make plans for the evening. It's nothing overly scripted—we just stay in touch the way any couple would."

Home & Living Situation

Q13: Do You Live Together Now? Have You Lived Together in the Past? When and Where?

This question helps confirm cohabitation, which is a strong indicator of a legitimate marriage. Officers want to see if your living history matches what's on your application and whether both spouses share consistent details about where and when you've lived together.

Sample Answer

"Yes, we live together now in a one-bedroom apartment in Atlanta. We moved in together in July 2022, about four months before we got married. Before that, we were spending a lot of time together but still had separate places. We decided to officially move in together once we knew the relationship was serious and long-term. Since then, we've been sharing the same home and building our daily routines together."

Q14: Describe Your Home Layout, Including Number of Rooms, Living Arrangements, and Toothbrush Placement.

Interviewers use this question to determine how well you know your shared living space. Couples who live together typically know where basic items are and can describe the layout of their home without hesitation.

Sample Answer

"Our apartment has one bedroom, one bathroom, a kitchen that opens into a small dining area, and a living room. When you walk in, the kitchen is on the right, and the living room is straight ahead. We keep our toothbrushes in the bathroom, in a single cup on the sink—mine is blue, and theirs is green. We also have a small shelf near the front door for keys and mail, and our cat's food bowl is just outside the kitchen entrance. Everything is pretty organized, and we each have our own spaces within the apartment, but we share everything."

Q15: What Color Are Your Curtains, Walls, Fridge. What Flooring.

These questions are meant to catch people off guard and see if both spouses can give matching answers about their home. It's a quick way to assess whether you actually live together and notice your surroundings.

"Our walls are a light beige color—standard for the apartment complex. The curtains in the living room are a dark gray, and we chose them together from Target. Our fridge is white, and we have a few magnets and a calendar stuck to it. The flooring in most of the apartment is a light wood-style laminate, but the bathroom and kitchen have tile. We didn't pick everything ourselves since it's a rental, but we've made it feel like home."

Finances & Future Plans

Q16: Do You Have Joint Bank Accounts, Credit Cards, or Shared Expenses? Who Pays Which Bills

This question helps verify that you're financially interdependent—one of the key signs of a bona fide marriage. Officers want to hear if you share money, expenses, or manage bills together, which reflects real life as a couple rather than a staged relationship.

Sample Answer

"Yes, we have a joint checking account that we opened a few months after getting married, and we use it to pay most of our shared bills like rent, utilities, and groceries. We each still have our own personal accounts too, but we make sure the joint one is used for anything household-related. I usually pay the rent and internet, while they handle the electric and water bills—it just worked out that way based on our pay schedules. We also have one shared credit card that we both use for larger purchases like travel or home items, and we always sit down together at the end of the month to review our budget."

Q17: What Are Your Future Plans—Children, Vacations, Large Purchases

This question explores whether the couple has discussed long-term goals, which is typical in genuine marriages. Officers want to see that you're building a future together, not just sharing a temporary situation.

Sample Answer

"We've definitely talked about our future. We're not in a rush to have children, but we both want to start a family in the next few years once we're more financially settled. Right now, we're saving up for a trip to Europe next summer—we've been dreaming about going to Italy together since we started dating. We're also planning to buy a car together by the end of the year, and eventually we want to own a home. These plans are important to us because they're not just goals—they're things we're actively working toward as a team."

Family & Social Life

Q18: Have You Met Each Other's Families. What Do They Think of Your Spouse.

This question helps determine how deeply involved each spouse is in the other's personal life. Meeting family members and having ongoing relationships with them suggests the marriage is genuine and not just for immigration purposes.

Sample Answer

"Yes, we've both met each other's families. My spouse met my parents during the holidays in 2021, and they immediately got along—my mom especially loves how respectful and thoughtful they are. I met their family at a cousin's wedding a few months later, and everyone was really welcoming. Since then, we've had regular dinners with both sides of the family and even spent Thanksgiving together last year. Both families are supportive of our relationship and treat us like we've been part of the family for years."

Q19: What Cultural Traditions or Celebrations Do You Share

Officers ask this to see how your lives blend together and whether you've embraced one another's backgrounds. Sharing traditions—religious, cultural, or family-specific—demonstrates a stronger emotional and lifestyle connection.

Sample Answer

"We come from different cultural backgrounds, but we've made it a point to embrace each other's traditions. My family celebrates Lunar New Year, and my spouse has learned how to make dumplings and participate in the festivities with my relatives. On their side, we celebrate Thanksgiving and Christmas with a big extended family gathering, which I really enjoy. We also started our own tradition of cooking a special meal together on our anniversary every year. It's been fun to blend old traditions with new ones that are unique to us."

Q20: Who Are Your Spouse's Siblings and Parents? Names, Birthdays

This question tests how well you know your spouse's family—people most married couples are naturally familiar with. Accurate answers show you've taken the time to know your partner on a deeper level.

Sample Answer

"My spouse's parents are Robert and Linda. Robert was born on March 3rd, and Linda's birthday is July 16th. They live in Florida and we talk to them at least once a week. My spouse also has one younger brother named Jason—his birthday is October 9th—and he just started college last year. We've spent time with all of them, especially during holidays and family get-togethers."
